Effective July 1, 2009, an additional assessment of **\$60** is now added to each new license application and license renewal, and will be applied to the Division's Insurance Administration and Enforcement Account. This fee and the Insurance Administration and Enforcement Account were created by the Legislature as a result of Senate Bill 426 which was signed by the Governor on May 29, 2009. This **additional assessment** is separate from, and in addition to, any business entity affiliation fee indicated in a license application or license renewal, or the fee to add an additional line of authority.
